We are currently reviewing our P-6 scope and sequence to develop ideas for the explicit teaching about online safety and are ensuring our ICT policies are up to date. We are also excited to have the co-founders Sam Macaulay and Trent Ray facilitate a live parent webinar for Cyber Safety and Wellbeing on the 18th July 2022. Age limits are imposed on social media apps for the reason that students at a certain age have the understanding, skills and responsibility to navigate through the platform independently (with the support of their family). It is a good idea to protect younger children from online risks, such as encountering harmful content, contact with strangers or missing out on physical activity. It is highly recommended these age restrictions are adhered to, but it is up to you to decide when and how to best support your children as they begin their online journey.
